pling biological populations, forestry and fisheries research, ecology, spatial data, statistical genetics, cohort and case-control studies, demography, epidemiology, pharmacokinetics, laboratory medicine, growth curves and longitudinal studies, carcinogenesis testing, survival analysis, clinical trials, multivariate analysis, analysis of binary data, regression methods, and multiple comparisons. In addition, there will be two sessions devoted to the Western North American Region student competition, and poster presentations of 25 papers.

Survial Analysis

A workshop on research in survival analysis will be held 25-26 July, 1986 at the University of Washington prior to the opening of the 13th International Biometric Conference.
